Applications must be received by Feb 18 to be considered part of initial sign-up. The priority for applications received in the initial sign-up follows these rules: First voting members of the Board of Directors who hold an elected or appointed position and who have served a minimum of one year on the Board of Directors at any time in the past. Board priority is based on the number of years on the Board. Then the general membership according to length of membership. All applications taken after the initial sign-up will be prioritized on a first come basis. The prices below are conservative estimates based on known fuel surcharges (none at this time).

Cancellation Policy: ANY PERSON WHO HAS A TRIP PAYMENT THAT IS 45 OR MORE DAYS OVERDUE IS SUBJECT TO BEING REMOVED FROM THE LIST OF TRIP PARTICIPANTS WITHOUT FURTHER NOTICE and refunds will be handled the same as cancellations.

Cancellations must be made in writing to Nils Jacobsen and refunds, will be made within 10 days except for funds for which the club is at risk. At risk funds will be held until after the trip. Club losses will be subtracted from the at-risk funds held, and the remainder will be returned.

Note: Many of our vendors have an escalating penalty policy the later cancellations are made. The club cannot guarantee that your spot can be sold to other members. To protect against these risks, members are encouraged to buy personal cancellation insurance.

If not, please be prepared to submit proof of insurance prior to any trip.
